

Tips to Protect Your Identity

- Avoid carrying sensitive documents, such as your Social Security card, passport or birth certificate. Keep these items safely and securely stored.
- Register your debit and credit cards at IDProtectMe247.com.
- Use strong passwords, combining sequences of upper and lowercase letters, symbols and numbers. Don't use easily accessible information like your name, date of birth, etc., as part of your password.
- Shred your bills and statements, or sign up to receive them securely online.
- If you're going out of town, place a hold on your mail through the U.S. Postal Service at usps.com.
- Place alerts on your credit file if you believe you are susceptible to or have been a victim of identity theft at fraudalerts.equifax.com.
- If your identity is compromised, call your dedicated IDProtect® Plus fraud specialist at 877-610-7889. They can help you start repairing your credit and protecting your identity immediately.
