

RBFCU Wi-Fi Terms and Conditions

Terms and Conditions:

Welcome to the RBFCU website which includes the support site and partner sites (the "Site").

By using our internet service, you hereby expressly acknowledge and agree that there are significant security, privacy and confidentiality risks inherent in accessing or transmitting information through the internet, whether the connection is facilitated through wired or wireless technology.
